



**MAXIMUM PENALTIES**

<b>ADULT</b>	<ul style="list-style-type: none"> <li>➤ A fine of \$2,650 for <b>any non-criminal (not jailable) or traffic offense</b></li> <li>➤ A fine of <b>\$2,650 or 364 days in jail OR both, fine and imprisonment</b> for any criminal violation in this Municipal Court. The following offenses may result in a jail sentence of up to 364 days of jail:</li> </ul>

<b>JUVENILE</b>	<ul style="list-style-type: none"> <li>➤ Maximum fine \$2,650.00. Failure to comply with a court order could result in a sentence to a juvenile detention facility up to 48 hours.</li> <li>➤ Your driver's license may be revoked if (1) you are convicted of possession of alcohol or marijuana by a minor and fail to complete a court ordered evaluation or treatment or (2) you are convicted of a second possession of alcohol/marijuana by a minor.</li> </ul>			

**DRIVER'S LICENSE POINT SUSPENSIONS**

Your license will be suspended if too many points are accumulated from traffic violations. In Colorado, a driver starts with 0 points and when convictions are reported to the Department of Motor Vehicles (DMV) points are added to the driver's record. A summary of the points bracket by age follows:

**PAYMENTS**

**The court expects you to pay ALL fines and court costs on the day you receive your sentence.** If you cannot, you may request a payment plan. In traffic cases, if you fail to pay or fail to appear before the Court and request an ability to pay hearing, the original charge will enter, and the original points will be reported to the DMV.
