Refuse Hauler's License Information

All refuse operators operating in the City of Federal Heights are required to obtain a current Refuse Haulers License. The application should be completed and mailed along with a check for \$100.00 payable to:

Refuse Haulers Licenses expire on December 31 each calendar year. Near the end of each calendar year, a license renewal application will be mailed to the address listed on the application. Once the applications are received, the Refuse Haulers License application will be reviewed and processed based upon the criteria delineated in the City of Federal Heights Municipal Code, Chapter 14 (§14-700 through §14-704).

§14-703 Refuse Haulers. Fee Payment License Requirement..

- a) Each licensee shall be required to pay an annual license fee of \$100.00 as established by resolution of city council.
- b) The hauler shall display on both sides of every vehicle used for refuse collection within the city the company name and telephone number in permanent, plain and legible figures, and letters, not less than three inches (3") in height and or a color contrasting to that of the body of such vehicle and said figures and letter shall be kept in such condition as to permit the same to be readily distinguished and visible.
- c) The equipment standards for each vehicle used in the collection of refuse shall at a minimum be as follows:
 - 1. A permanent cover which encloses the entire area of any open body truck.
 - 2. A truck body constructed so as to be permanently leak proof.
 - 3. Any extension of sideboards or tailgate shall be of a permanent material.
- d) It shall be unlawful to operate any vehicle used for the collection of refuse with the tailgate or any side gate at an open or down position, or without the cover for the entire open area of the body of such vehicle being securely fastened so as to cover such entire open area, or in such manner as to litter any place or area with refuse
- e) It shall be unlawful for any refuse hauler to fail to immediately remove all refuse spilled or deposited upon any city street or right-of-way.
